In addition, the undersigned hereby authorizes those contacted to release any and all information that may be helpful in determining whether or not credit should be extended.



## CREDIT APPLICATION AND AGREEMENT

If credit is extended, Applicant acknowledges that BigRentz requires payment upon due date of each invoice. Invoices are considered past due after the due date of such invoice. On any past due balances, Applicant agrees to pay BigRentz upon demand, any and all costs, expenses, and fees, including a finance charge of 1.5% per month and reasonable attorneys' fees incurred in enforcing payments due to BigRentz from Applicant or Guarantor(s) (regardless of whether suit is commenced). In the event suit is brought to enforce payment, that such suit (and any related costs, fees, and expenses) shall be determined by a court sitting without jury. At the discretion of BigRentz, any account with a delinquent balance may be placed on a prepaid/cash basis at any time, and BigRentz may pick up the equipment without notice to Applicant. BigRentz reserves the right to file preliminary lien notices and/or mechanics liens for work done in states where these notices are required by state law in order to protect its' lien rights.

This agreement shall be governed by the laws of the state of California. The parties agree that jurisdiction and venue for all disputes arising from the subject matter of this contract shall be in Orange County, California at the option of BigRentz. Should any aspect of this agreement be determined unenforceable, then all other aspects shall remain valid and binding and the provisions hereof are severable.
