DEFAULT AGREEMENT

Should any aspect of this agreement be determined unenforceable, then all other aspects shall remain valid and binding and the provisions hereof are severable.

GUARANTEE

In further consideration of any extension of credit the undersigned guarantors jointly and severally hereby guarantee payment of any indebtedness arising hereunder when due (including future advances of credit), together with finance charges, cost, and attorney's fees (incurred before, after or regardless of whether suit is filed in collecting payments due BigRentz, including, without limitations, under this guarantee). The guarantor's obligation under this guaranty is independent of the obligations of any company named as applicant herein, and a separate action or actions may be brought and prosecuted against guarantors whether or not action is brought against the applicant. Guarantors consent to extensions of time to pay, future advances and increases in credit, or other arrangements or indulgence as to payment by applicant and waive notice as to the same. To the maximum extent enforceable by law, Guarantors waive all defenses arising as a result of any disability or bankruptcy of the applicant. Any indebtedness of applicants to guarantor now or hereafter is hereby subordinated to the indebtedness of applicant to BigRentz.com. Each guarantor waives any right to require BigRentz to (A) proceed against the applicant or any other guarantor, (B) proceed against or exhaust any security given by applicant or any other guarantor, or (C) pursue any other remedy in BigRentz's power whatsoever. This guarantee shall be continuous and irrevocable. MANDATORY ARBITRATION. If a dispute arises from or relates to this Guarantee and a breach of it, the guarantor(s) agree the dispute shall be settled by arbitration administered by the American Arbitration Association ("AAA") in accordance with its Commercial Arbitration Rules and the Expedited Procedures contained therein if applicable, and judgment of the award rendered by the arbitrator may be entered in any court having jurisdiction thereof. Arbitration shall be initiated by filing a demand with AAA with notice thereof given to the other party. The arbitrator shall have exclusive authority to resolve the dispute, including but not limited to, the interpretation, applicability, enforceability, validity or formation of the Guarantee, any claim that all or any part of the Guarantee is void or voidable, and any claim arising out of the terms and conditions of the Guarantee or involving the rights and obligations of the parties hereto or its breach. The applicant and guarantor(s) may be joined in the same arbitration proceeding should BigRentz elect to do so. The proceedings before the AAA may be heard by telephonic means according to the parties mutual consent; otherwise the in-person arbitration hearing shall be held in the City of Irvine, California.
